Filings Access is a mobile-friendly, web application that your constituents can use to fill out any form that gets filed at the county. This could include business name registrations (FBN, DBA, Assumed Names), liquor licenses, environmental filings, pet licenses, and more. The solution's integration with Enterprise Records Management means no additional data entry is required to complete requests. With capabilities for identity verification, document upload, electronic certified copies, expedited shipping, and payments, this solution streamlines county processes.

Filings Access is conveniently available to your constituents through the Records Access Portal. Vitals Access is also available in this portal, which can be used by your constituents to submit vital record requests.


Transform the efficiency of your office by offering online access to submit forms for filing.

- Utilize batch reconciliation to simplify your daily processes.
- View real-time payment processing with updates to payer account balances immediately.

With enhanced security measures in place, you can rest assured the integrity of information submitted electronically will not come into question. This solution ensures compliance with legal requirements and regulations associated with assumed names and fictitious business names, and other required filings. And the integrated payment solution is compliant with PCI/PA-DSS, making it reliable and secure.

When it comes to the management of user accounts and passwords for the portal, your staff does not have to get involved. This solution allows users to either register for an account through the portal or log in using an existing Google, Facebook, or Twitter account, which all have their own advanced security measures in place.
