




#### Manage Your Law Enforcement Data

The Tyler Criminal Justice Information System application include features for managing every part of an incident case from intake to promotion to investigations, and of an investigatory case from receipt to closure, while ensuring the interests of all parties are protected. Incidents are identified as criminal, non-criminal, civil, or internal cases. Depending on the type of incident, the system applies different workflows and tracks different data. Fully configurable, the application offers modules specifically for Incident Management and Investigation Management.

#### Incident Management

As soon as a crime or infraction is reported, data about that incident must be meticulously captured. Law enforcement personnel, particularly first responders, need accurate, complete information when they arrive at the scene. The Incident Management module can be used on a mobile device to allow field personnel to capture real-time information received from computer aided dispatch (CAD) systems, automatic vehicle location (AVL) software, automated license plate recognition (ALPR) equipment, and other mobile solutions that pre-populate the incident report.

At the scene or back in the office, the Incident Management module takes the officer through workflows configured specifically by your agency, such as capturing witness statements. Customizable online citations, face sheets, and other forms can be quickly filled out, submitted, and approved. Public portal functionality extends the reach of your law enforcement officers, giving citizens the ability to submit tips and report crimes. At every step, the system captures the data and ensures that it is merged with the associated case.

# Mobile data collection Collect data in the field with the optional Data Collect Mobile module. This module works on mobile devices to support inspections, investigations, reporting, and evidence collection. It allows users to collect and log information remotely, and if the officer does not have an internet connection the application can work offline until a connection is reestablished. It replaces traditional note-taking methods with documentation that can be completed on-the-go to create configurable, easy-to-share reports.

#### **Evidence management**

Organize and manage access to evidence. Users can log evidence and link it to the appropriate digital case file. The application generates evidence tags, logs, and chain of custody data. Barcode scanning and versions of evidence tags identify the appearance and location of all pieces of evidence. The application can also be used to manage evidence disposal processes in accordance with your policies.

#### Public portal

Empower citizens to report crimes, submit tips, and share photos and videos with the optional Access portal. It enables law enforcement to partner with citizens and fosters secure community engagement.

#### **Court administration**

Automate the collection, imaging, organization, and retrieval of case data for trial, while also creating calendars and reports.

Appellate case files are automatically generated and indexed from scanned motions, hearings, evidence, and other documents. A centralized accounting system makes it easy to manage collections and payments.



### Corrections population management

Give corrections officials the tools to track everything from history of inmates to court cases and grievances. Dashboards help monitor populations, identify safety risks, and comply with state and federal reporting requirements. The application also gives you the ability to manage offender custody movement, status, and actions within detention centers/jails, prisoner property, court transfers, and more.

#### Parole and probation oversight

Document the conduct and compliance of individuals under parole and probation supervision. The single shared platform

facilitates frequent communication between law enforcement, parole and probation officers, and courts regarding progress or violations.

#### Reporting

Track every detail and every stage, using the application to easily generate reports as a byproduct of investigation activities instead of another item
